The conditions of providing services on contract basis are as follows:-

- (i) Posts advertised shall be filled up only on contractual basis initially for a period of one year. The contract can further be extended up to 11th plan period on the basis of performance appraisal report.
- (ii) The total number of vacancies as indicated above will be filled up as per the requirement strictly in accordance with merit.
- (iii) Period of providing services would be for a maximum period of the programme.
- (iv) Monthly Performance Monitoring and Appraisal would be carried out to ensure achievement of the objectives behind this arrangement.
- (v) The contract shall be effective from the date of actual contractual engagement.
- (vi) The selected personnel would assist the Secretary Agriculture/Director Agriculture/State Nodal Officer/Director, State Agricultural Management & Extension Training Institute/Project Director as the case may be in carrying out various functions and also carry out the instructions issued by Department of Agriculture & Cane Development, Govt. of Jharkhand from time to time in a time bound manner.
- (vii) Reservations as per the policy of Government of Jharkhand shall be applicable.
- (viii) Successful candidates on contract basis will have to sign a contractual agreement with the Director, State Agricultural Management & Extension Training Institute, Jharkhand.
- (ix) Candidates applying for the post of Project Director and Deputy Project Director will have to indicate his/her choice for respective district in separate sheet for providing services in the order of descendance preference on contractual basis in various Agriculture Technology Management Agency districts. In light of which, the selected candidates would be assigned contract in various districts as per the combined merit list and such preference indicated subject to availability of the vacancy in such districts, who accordingly have to join the assigned district to provide the desired services.
- (x) The contractual engagement shall not confer any right or claim of extension/absorption in the district under the Agriculture & Cane Development Department, Govt. of Jharkhand.
- (xi) Candidate will have to undergo a Written Test/Interview.
- (xii) Accordingly, interested and eligible candidates are invited to submit applications in the prescribed format along with attested copies of mark sheets, caste certificate, professional qualification, experience with pay slip for the support of existing pay scale etc. and an application fee of Rs. 500/- (Rupee Five Hundred Only) for the post of Deputy Director /Project Director/Deputy Project Director in the form of Demand Draft in favour of Director, SAMETI, Jharkhand payable at Ranchi.
- (xiii) Interested candidates can download the application format and other details from the website www.sameti.org of SAMETI, Jharkhand.
- (xiv) Duly filled in computerised applications (in A4 size paper as per the prescribed format available at www.sameti.org) should reach the Office of the Director, SAMETI, Krishi Bhawan Campus, Kanke Road, Ranchi - 834008 (Jharkhand) on or before 5.00 pm after fifteen (15) days from the date of publication of advertisement through Registered/Speed Post only. No application will be received in SAMETI Office directly.
- (xv) The Director, State Agricultural Management & Extension Training Institute, Govt. of Jharkhand shall not be responsible for any delay in receipt of the application. Application received after the due date and time shall not be entertained.
- (xvi) No traveling allowance etc. will be admissible to the candidates for appearing in written test or interview.
- (xvii) Preference will be given to the candidate for the post of Dy Director and Dy Project Director working under SAMETI/ATMA/Qualified in Post Graduate Diploma in Agricultural Extension Management (PGDAEM).
- (xviii) A waiting list of the candidature will be prepared for each post, which will be valid for one year and vacancies will be filled from the waitlisted candidates in order of merit.
