The conditions of providing services on contract basis are as follows:-

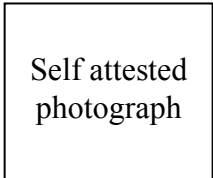
- (i) Posts advertised shall be filled up only on contractual basis initially for a period of one year. The contract can further be extended on the basis of performance appraisal report up to Project Period.

- (iii) Period of providing services would be for a maximum period of the programme.
- (iv) Monthly Performance, Monitoring and Appraisal would be carried out to ensure achievement of the objectives behind this arrangement.
