2.0 SCOPE OF WORK

4.4 Relevant documents in support of the above criteria should be submitted along with proof, so as to enable appropriate marking.

6.0 SELECTION PROCESS

A nominated Committee will evaluate the technical bids received. Technical assessment will be based on technical evaluation criteria as mentioned in paragraph 4.3.

On the basis of technical assessment, top competitive organization scoring more than 60% separately in criteria :-Aø & :-Bø in technical assessment will be selected and the financial packet only of these agencies will be opened.

The financial proposal for conducting aforesaid evaluation study shall be considered separately on the basis of the financial bid submitted.

The job for conducting aforesaid evaluation study will be awarded to the organization, who quotes the minimum price specified in the EOI document.

7.0 SELECTION OF EVALUATION AGENCY

The Agency quoting the lowest rate for conducting evaluation study of projects & work specified/ similar work as in **Annexure- I** & covered under Jharkhand State would be selected, as per the requirements within the specified time limit.

8.0 CERTIFICATE OF CONFIRMITY

9.0 BLACKLISTING DEBARMENT

15.0 VALIDITY PERIOD

16.0 OTHER IMPORTANT INFORMATION

16.1 The Competent Authority is not bound to accept the lowest rate or any tender or to assign any reason for non-acceptance. The Competent Authority reserves its right to accept the tender either in full or in part. Conditional Bids will be rejected outright.

16.2 The Competent Authority reserves the right to summarily reject an offer received from any organizations on national security considerations, without any intimation to the bidder.

17.0 PENALTY CLAUSE

17.1 If studies are not completed within given time frame maximum 5% penalty of the work order value will be charged per month.
